Clark County Credit Union Bonus Cruise Giveaway OFFICIAL RULES

Qualified Deposit Product: There is one (1) method of qualification.

1. To enter, open a new Bonus Checking account with Clark County Credit Union with a minimum of \$15,000 (fifteen thousand dollars) AND maintain an average daily balance of \$15,000 or more for 90 days before the end of the corresponding draw period (see table above).
