

Fire Up Your Finances Sweepstakes Official Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES.

SPONSORSHIP: Yolo Federal Credit Union (Yolo FCU), a federally chartered credit union with a principal office located at 266 W. Main Street, Woodland, CA 95695, is sponsoring the Yolo FCU's Fire Up Your Finances Sweepstakes ("Sweepstakes").

ELIGIBILITY: To enter the Sweepstakes, you must be a lawful permanent resident of the United States, 18 years of age or older, and must not be considered a minor in your state of residence. The Sweepstakes is void in Puerto Rico, U.S. territories and possessions, outside of the United States, and where restricted or prohibited by law. Credit Union employees, officials, and members of their immediate families and households are not eligible to participate in the Sweepstakes.

HOW TO ENTER: The Sweepstakes begins on May 1, 2024, and ends on July 31, 2024, ("Sweepstakes Period"). There are two ways to enter: (1) schedule a Real Estate Review during the promotional period, or (2) by completing the online entry form on our website. Entrants must complete one mode of entry between the Sweepstakes Period to qualify. One entry per person. Once submitted, entries become Yolo FCU's sole property and will not be acknowledged or returned. No copies or mechanical reproductions of entries will be accepted.

DRAWING: A random drawing will be held for the qualifying entries received during the Sweepstakes Period. Three (3) potential winners will be selected from all eligible entries received during the Sweepstakes Period described below by a Yolo FCU Representative. In the event of uncertainty as to an entrant's identity, the entry may be voided altogether. Odds of winning the prize depends on the number of entries received. The potential winner will be notified by phone or e-mail. If a potential winner cannot be reached within 5 business days from the first notification attempt, then such person shall be disqualified, and an alternate winner will be selected.

Three winners will be selected. The winner will be notified by August 15, 2024. Yolo FCU will report all prize winnings to the appropriate state and federal agencies, as required by applicable law. Winner is responsible for all tax consequences (if any) of the prizes. Winner acknowledges this responsibility by entering the sweepstakes.

PRIZE CONDITIONS: In the event a Yolo FCU representative determines, in its sole discretion based on his/her interpretation of these Official Rules, that an entrant is found to be ineligible, or if he/she does not comply with these Official Rules, then the potential winner will be disqualified and an alternate winner will be selected through a random drawing from the remaining entries. If the prize or prize notification is returned as undeliverable, this will result in disqualification, and an alternate winner will be selected. Except where prohibited by law, the winner's entry and acceptance of the prize constitutes permission for Yolo FCU to use said winner's name in all forms of media, in perpetuity, without further compensation.

SWEEPSTAKES CONDITIONS: This Sweepstakes is subject to all applicable federal, state, and local laws. By participating, entrants and their participating entities agree to be bound by these Official Rules and the decisions of Yolo FCU and waive any right to claim ambiguity in the Sweepstakes or these Official Rules. Yolo FCU is not responsible for any incorrect or inaccurate information, whether caused by tampering, hacking, or by any of the equipment or programming associated with the Sweepstakes. Prizes cannot be substituted, assigned, or transferred by winner. Yolo FCU reserves the right to disqualify entrants who fail to follow these Official Rules and regulations or who make any misrepresentations relative to the Sweepstakes and redemption of a prize.
