

Yolo FCU's Natomas Survey Sweepstakes Official Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES.

SPONSORSHIP: Yolo Federal Credit Union (Yolo FCU), a federally chartered credit union with a principal office located at 266 W. Main Street, Woodland, CA 95695, is sponsoring the Yolo FCU's Natomas Survey Sweepstakes ("Sweepstakes").

ELIGIBILITY: To enter the Sweepstakes, you must be a lawful permanent resident of the United States, 18 years of age or older, and must not be considered a minor in your state of residence. The Sweepstakes is void in Puerto Rico, U.S. territories and possessions, outside of the United States, and where restricted or prohibited by law. Credit Union employees, officials, and members of their immediate families and households are not eligible to participate in the Sweepstakes.

HOW TO ENTER: The Sweepstakes begins at 12:01 a.m. PST on May 5, 2024, and ends at 11:55 p.m. PST on May 5, 2024 ("Sweepstakes Period"). To enter, (1) visit the Yolo Federal Credit Union booth at the Fiesta Cinco de Mayo en la Natomas event located at South Natomas Community Park, 2881 Truxel Rd., Sacramento, CA 95833 and complete the online survey, or (2) complete the online form at YoloFCU.org/benefits. Entrants must complete the online survey or form during the Sweepstakes Period to qualify. One entry per online survey per person. Once submitted, entries become Yolo FCU's sole property and will not be acknowledged or returned. No copies or mechanical reproductions of entries will be accepted.

DRAWING: A random drawing will be held for the qualifying entries received during the Sweepstakes Period. The potential winner will be selected from all eligible entries received during the Sweepstakes Period described below by a Yolo FCU Representative. In the event of uncertainty as to an entrant's identity, the entry may be voided altogether. Odds of winning the prize depends on the number of entries received. The potential winner will be notified by phone or e-mail. If a potential winner cannot be reached by noon from the first notification attempt, then such person shall be disqualified, and an alternate winner will be selected.

PRIZES: The prize will consist of one (1) Visa eGift Card valued at \$100. Only one winner will be selected. The winner will be notified by Friday May 10, 2024. Yolo FCU will report all prize winnings to the appropriate state and federal agencies, as required by applicable law. Winner is responsible for all tax consequences (if any) of the prizes. Winner acknowledges this responsibility by entering the sweepstakes.

PRIZE CONDITIONS: In the event a Yolo FCU representative determines, in its sole discretion based on his/her interpretation of these Official Rules, that an entrant is found to be ineligible, or if he/she does not comply with these Official Rules, then the potential winner will be disqualified and an alternate winner will be selected through a random drawing from the remaining entries. If the prize or prize notification is returned as undeliverable, this will result in disqualification, and an alternate winner will be selected the prize constitutes permission for Yolo FCU to use said winner's name in all forms of media, in perpetuity, without further compensation.
